

Terms and conditions participation Time out Tune in program

Entry

Registration takes place by registering and agreeing to the Terms and conditions. The participant will then receive an invoice for the program. The application for the program is accepted by a written confirmation of participation and after receipt of the total amount by the organization of Time out Tune in.

Participants

There is room for a minimum of 3 and a maximum of 5 participants per session. The organization of Time out Tune in can cancel the participation in the program if there are fewer participants than the minimum number.

Liability/ insurance

The organization of Time out Tune in exercises as much care as possible with regard to the organization and the realization of the program. This also applies to the cooperation with local organization through Muweti Bush Lodge. But Time out Tune in is not liable for damage in connection with the program, including the stay in South Africa and / or the acts or omissions of the guides and / or the local organization. This exclusion also applies to all possible health and safety risks and loss/damage to luggage. But not in case of intent or deliberate recklessness and in case of damage caused by death or injury of the participant. The participant must take out an appropriate travel and cancellation insurance to cover the risks associated with staying in the nature reserve in South Africa. These risks are discussed during the introductory group meeting. The organization of Time out Tune in is not liable for damage that is covered by insurance of the participant, such as travel, health care and cancellation insurance. The participant must ensure that his/her mental and physical condition allows him/her to participate in the program.

Cancellation

In the unlikely event that the participant has to cancel the participation in the program, the following cancellation costs apply:

- Cancellation 15 – 28 days before departure: 50% of the price
- Cancellation < 15 days before departure: 100% of the price

The cancellation must be made in writing. If the participant wants to let another participant go in his / her place, an administrative fee of € 100 applies. This

participant is admitted to the program on condition that the organization of Time out Tune agrees to this. We reserve the right to reject the proposed replacement.

Covid-19

If the situation in South Africa changes, the program might (last-minute) not continue. In consultation with the organization of Time out Tune in, the group can be moved to a new date / session free of charge. If a participant gets covid-19 just before departure or gets covid-19 complaints and can no longer have a test done, the participant can no longer participate in the program. In that case, the conditions as stated in Cancellation apply. Any additional travel and accommodation costs when a country/region goes into lockdown during the program are for the participant. Should the Dutch government decide in the coming period to introduce a quarantine obligation for people returning from South Africa, this is not a reason for free cancellation/relocation in advance. In that case, too, the conditions as stated in Cancellation apply. The participant must check the conditions of his own travel and health insurance. The starting point for the program are the current covid-19 measures of the Dutch government and the government of South Africa.

Changes to terms and conditions

The organization of Time out Tune in can change these conditions for important reasons.
